## SUMMARY:

In this general practitioner's role, the Staff Attorney assists in such areas as compliance, contract review and negotiation, intellectual property, and healthcare law, with particular emphasis in transactional work, regulatory due diligence, and contracting. All responsibilities are performed in accordance with and to promote Heartbeat International's pro-life mission and vision and Christian core beliefs and core operational values.

#### **JOB RESPONSIBILITIES:**

#### **Primary Responsibilities**

- 1. Support General Counsel in responding to immediate need for legal action in time-sensitive circumstances.
- 2. Represent HBI as indicated in court and before quasi-judicial or administrative agencies of government.
- 3. Maintain superior quality of all legal papers via review and editing
- 4. Provide legal advice regarding laws, rulings, and regulations for HBI and, as indicated, for Heartbeat programs and Heartbeat affiliates.
- 5. Support Development team by accepting various opportunities to promote HBI's services to our ministry friends.
- 6. Network and develop relationships with attorneys who support HBI's mission.
- 7. Prepare and update affiliate legal educational materials.
- 8. Author articles in support of affiliate education needs or legal topics related to pregnancy help.
- 9. Assist in facilitating and in review of affiliate legal audits.
- 10. Draft and review contracts, employment agreements, and a variety of other legal correspondence.
- 11. May supervise the work of HBI paralegal, or outside and/or pro bono counsel.

#### Secondary Responsibilities

- 1. May develop and deliver presentations for conferences, trainings, consultations, etc. for Heartbeat International to train and inspire attendees in legal education important to HB's and affiliates' Christian prolife mission/vision.
- 2. Accept assignments not specifically delineated above as requested by the General Counsel.

## SUPERVISION (Received/Exercised)

Works from Heartbeat offices, or off-site at times, and receives periodic supervision through the assignment of special projects and setting of project goals/objectives by the General Counsel and evaluation of results with periodic updating. Periodic reporting of general operations. May supervise interns and/or support staff.
